1	<p><b>JOHNSON, KYLE</b> • Report this narrative to OSBI? <b>NO</b></p> <p>Crime Type: Information</p> <p>Case #: 16-1249</p> <p>Address: ████████████████████</p> <p>Date: June 25th, 2016</p> <p>Time: 11:00 AM</p> <p>Reporting Person: Scott Christy</p> <p>Deputy Summary: I Deputy K. Johnson was dispatched to 22749 E 141st St S to investigate persons possibly impersonating public officials. Upon arrival I made contact with Scott Christy.</p> <p>Reporting Party Summary: Scott Christy stated he and his ex-girlfriend (Rebecca Hendricks) made an agreement for their son Sterling to stay with him from Friday night until noon on Saturday. Scott later asked if Sterling could stay until 3:00 pm so his mother (Sharnell Sanders) could see him for a few hours. Rebecca then told Scott "That's not going to happen.". An hour later Rebecca arrived with her mother (Lori Hendricks) and two persons stating they were with the Wagoner County District Attorney's Office. The female District Attorney told Scott that he has no legal rights to his son and needs to give him back to Rebecca. Scott said he was intimidated by their presence, and gave Sterling to Rebecca out of fear of being arrested. Scott added that he is the biological father of the child and did sign an AOP (Acknowledgment of Paternity) at the time of birth.</p> <p>Witness Summary: Sharnell Sanders stated Jack Thorpe and a female claiming to be a Wagoner County District Attorney arrived at her house along with Rebecca and Lori Hendricks. The female District Attorney stated her son (Scott Christy) has no legal rights to the child, and that he must give the child back to Rebecca. Sharnell said there is no court order or custody agreement between Scott and Rebecca, and that they have been sharing equal time with the child until this point. Sharnell stated they complied with the District Attorney because she did not want to go to jail.</p> <p>Deputy Actions: I obtained witness statements from Scott Christy and Sharnell Sanders. The female District Attorney was identified as Joy Mohorovicic by viewing photos from her Facebook profile.</p> <p>Additional: Prior to being dispatched to the above incident, I received a citizen call back request from Rebecca Hendricks at 918-829-5194. Upon making contact with Rebecca, it was stated that she wants me to go take her child away from the father. I asked if there was a custody agreement in place or if she had a decree from a Judge or court. Rebecca stated that she has no decree, and there is no custody agreement. I then asked if the person the whom child is with would be the biological father, to which she replied "Yes." I stated to Rebecca that she must have a custody agreement, a writ of assistance, or a decree from a judge or court identifying HER as the CUSTODIAL PARENT (reference O.S 21-567) in order for me to intervene in civil child custody situations.</p>

<p>Additional: After ending the phone call with Rebecca, I received a call from Deputy Aaron Torix. He began asking questions in reference to my conversation with Rebecca Hendricks. After disclosing the details of the conversation, he was in agreement with my statements. Deputy Torix said he received a phone call from Sheriff Dan David whom had instructed him to proceed to the residence and relieve the child from his father. I advised Deputy Torix that we can not do that, as it would be an unlawful seizure. It was determined that Deputy Torix would contact Sheriff David to allow full details from both sides of the dispute to be heard before proceeding to the residence. Prior to our arrival, Deputy Torix called me to advise that the situation had been taken care of and our assistance was no longer needed. Approximately 20 minutes later, we were dispatched to the above residence to investigate impersonation.</p>

<p>On 06/26/16 at approximately 0800hours I, Investigator Elliott was contacted by Wagoner County Sheriff's Deputy, Kyle Johnson. Johnson called to get information on Child Custody Laws in Oklahoma. Johnson stated that he was trying to figure out if he had done anything wrong on a call he had received the day prior. (06/25/16)</p> <p>"urn:schemas-microsoft-com:office:office" /&gt;</p> <p>Johnson stated that on the morning of 06/25/16, he had received a request from Wagoner County Dispatch (WCD) to contact a Rebecca Hendricks via cell phone. (10-21 Request) Johnson stated that Rebecca told him that she wanted a Deputy to go pick up her child from the biological father, Scott Christy. Johnson stated that he asked Rebecca if there was a court order, custody agreement, or a writ that stated that the child should be taken from the father. Johnson stated that Rebecca stated No. Johnson stated that he explained to Rebecca that Law Enforcement could not just go take the child, and this would be considered a civil matter. Johnson stated that at no time did Rebecca state that she thought the child's welfare was in danger. The 911 call that Rebecca had originally placed to WCD, does not reflect any statements of child welfare issues.</p> <p>Johnson stated that later he was contacted by Wagoner County Sheriff's Deputy, Aaron Torix. Johnson stated that Torix told him that he had received instructions from Wagoner County Sheriff, Dan David. Johnson stated that Torix told him that Sheriff David told them to respond to the address of the biological father, and assist with the recovery of the child to the mother. Johnson stated that Torix said he would take care of it.</p> <p>During the course of my investigation of events, I learned that Jack Thorp, Joy Mohorovic, Lori Hendricks, and Rebecca Hendricks arrived at Christy's address, 22749 E 141st St S, Coweta, prior to Torix arriving. I learned that Rebecca left Christy's residence with the child. I learned that Mohorovic instructed Torix that he did not need to arrive, and that the mother had left with the child.</p>	

During the course of my investigation of events, I learned that Torix and Johnson were dispatched by WCD, to respond to Christy's residence on a complaint of false impersonation. According to Torix and Johnson, Scott Christy and his

mother, Sharnell Sanders, wanted to file charges on Thorp and Mohorovic for abusing their power, and abusing their 4th Amendment rights, by threatening arrest if Christy and Sharnell did not return the child to Rebecca. A report was generated.

On 06/26/16, I informed

Sheriff David of all the information that I had gained so far on this incident. Sheriff David instructed me to collect witness statements from all parties involved, and present my findings.

3 ELLIOTT, DANNY • Report this narrative to OSBI? NO

On 06/27/16 I, Investigator Elliott continued my investigation per Sheriff David. I obtained written statements from Deputy Johnson, and Deputy Torix. I made contact with Lori Hendricks, and her daughter, Rebecca Hendricks. I had Lori and Rebecca fill out written statements on the events that happened at the residence of Scott Christy. I obtained a written statement from Sheriff David to his involvement. I interviewed and obtained oral statements from ADA Joy Mohorovic, and ADA Jack Thorp.

In an interview with Rebecca Hendricks, Rebecca stated that her ex-boyfriend, Scott Christy is the father of their child. Rebecca stated that Christy is the biological father, and is on the child's Birth Certificate. Rebecca stated that she and Christy had made an agreement, that Christy would keep their child for a visitation on Friday night, 06/24/16, and Christy would return the child on Saturday at 0900hours 06/25/16. Rebecca stated that she had received a phone call from Christy asking if he could keep their child longer. Rebecca stated that an argument ensued, and Christy told Rebecca that he was taking their child to Reno Oklahoma with him. Rebecca stated that Christy told her that she would have to get Law Enforcement involved to get their child back.

Rebecca stated that she did not feel the welfare of the child was at risk. When asked, Rebecca stated that Christy had broken her phone in the past, and pushed her a long time ago. Rebecca stated that Christy was "violent." When asked what "violent" meant, Rebecca stated that he yells a lot. When asked if Christy had ever been violent with their child, Rebecca stated that Christy had "spanked" their son on 2 different occasions. Rebecca stated that neighbors had called the police in the past because Christy was yelling. When asked, Rebecca stated there had been no police reports filed for domestic violence.

Rebecca stated that she had contacted the Wagoner County Sheriff's Office, to have a Deputy go pick up her child from Christy's residence. Rebecca stated that when the Deputy declined her request, she contacted her mother, Lori Hendricks, who in turn contacted Jack and Joy. Rebecca stated that when she, Lori, Jack, and Joy arrived at Christy's residence to retrieve the child, Christy became angry. Rebecca stated that Jack and Joy were identified by Christy to be from the DA's Office. Rebecca stated that Joy told Christy, and his mother, Sharnell Sanders, that Christy did not have legal rights to the child. Rebecca stated that Christy was yelling and waving his arms. Rebecca stated that Christy threatened Jack, but only yelled. Rebecca stated that Joy told Christy that a Deputy was in route to the residence. Rebecca stated that at that point, Sharnell handed the child to Rebecca. Rebecca stated that after she received her child, they all left the residence.

On 06/27/16 I, Investigator Elliott conducted interviews with ADA's Jack Thorp and Joy Mohorovic. Jack and Joy came to my office and offered oral statements. Statements were given separately.

In an interview with Jack Thorp, Jack stated that he received a phone call from Joy Mohorovic. Jack stated that Joy told him that she had received a call from Lori Hendricks, and that Lori's daughter, Rebecca Hendricks' ex-boyfriend would not return her child to her. Jack stated that he, Joy, Rebecca, and Lori, all traveled to the residence of Scott Christy (Rebecca's ex-boyfriend's residence) Jack stated that

when he arrived, Lori and Rebecca were already at the residence. Jack stated that he parked his vehicle on the street in front of the residence. Jack stated that shortly after he arrived, Joy arrived, and parked behind his vehicle. Jack stated that he stood on the street beside his vehicle, and was there to make sure nothing bad happened. Jack stated that he never moved from the spot he was standing during his time at the residence.

Jack stated that while he was there, Christy was yelling and flailing his arms in an angry fashion. Jack stated that Christy asked him if he was Jack Thorp from the DA's office. Jack stated that he told Christy his name was Jack, but he was there as a "private actor." Jack stated that Christy got into Jack's face and appeared to lure Jack into an altercation. Jack stated that Christy called Jack a "fucking clown." Jack stated that after Joy talked to Christy, and his mother, Sharnell Sanders, that Sharnell eventually gave the child to Rebecca. Jack stated that after Rebecca obtained the child, he, Joy, Lori, and Rebecca, left the residence.

In an interview with Joy Mohorovic, Joy stated she had received a call from Lori Hendricks. Joy stated that Lori told her that Lori's daughter, Rebecca Hendricks could not get her child from her ex-boyfriend, and Deputies with the Wagoner County Sheriff's Office would not help Rebecca. Joy stated that Rebecca told her that her ex-boyfriend, Scott Christy was violent, and had hit Rebecca in the past. Joy stated that she contacted Sheriff David. Joy stated she informed David about the situation, and the law says that Christy had no parental rights to the child. Joy stated that she informed Sheriff David that she and Jack were going to Christy's residence to assist Rebecca.

Joy stated that when she arrived, Lori, Rebecca, and Jack had already arrived. Joy stated that Christy was visibly angry. Joy stated that Christy was cursing, and waving his arms. Joy stated that she heard Christy call Jack a "fucking clown." Joy stated that at some point Christy understood that she and Jack were from the DA's Office. Joy stated that she told Christy that she and Jack were not there in an official capacity. Joy stated that she spoke to Christy's mother, Sharnell Sanders. Joy stated that she told Sharnell that as she(Joy) reads the law, Christy does not have custodial rights on child visitation. Joy stated that she informed Christy and Sharnell that a Wagoner County Deputy was in route to the residence. Joy stated that Sharnell attempted to calm Christy down. Joy stated that Sharnell gave the child to Rebecca. Joy stated that after Rebecca obtained the child, she, Lori, Rebecca, and Jack left the residence.

CALL. UPON ARRIVAL WE MADE CONTACT W/ R/P SCOTT CHRISTY AND WITNESS SHARNELL SANDERS.

REPORTING PARTY SUMMARY: SCOTT STATED HE HAD HIS SON (STERLING) OVER NIGHT FRIDAY (6-24-16 TO 6-25-16). SCOTT SAID HE AND HIS EX- GIRLFRIEND (REBECCA HENDRICKS) AGREED THAT HE COULD KEEP HIM UNTIL SATURDAY (6-25-16) AT NOON. SCOTT ADVISED HE CALLED EARLY SATURDAY MORNING TO SEE IF HE COULD KEEP STERLING LONGER, SO HIS MOM COULD SPEND TIME WITH HIM. REBECCA INFORMED SCOTT THAT WASN'T GOING TO HAPPEN. APPROXIMATELY AN HOUR LATER REBECCA SHOWS UP WITH HER MOTHER (LORI HENDRICKS) AND TWO PEOPLE ONE MALE (JACK THORPE) AND ONE FEMALE (JOY MOHOROVICIC) CLAIMING TO BE WAGONER COUNTY DISTRICT ATTORNEYS. SCOTT SAID THE FEMALE DISTRICT ATTORNEY TOLD HIM HE HAD NO LEGAL RIGHTS TO THE CHILD AND THAT LAW ENFORCEMENT WAS EN ROUTE. SHE SAID HE NEEDED TO GIVE THE CHILD TO HIS MOTHER. SCOTT ADVISED HE DIDN'T KNOW WHAT TO DO SO HE GAVE STERLING BACK TO REBECCA. SCOTT STATED HE HAS TWO CHILDREN WITH REBECCA AND ONE ON THE WAY. SCOTT SAID HE IS THE FATHER AND SIGNED AN AOP (ACKNOWLEDGEMENT OF PATERNITY) WHEN STERLING WAS BORN.

WITNESS SUMMARY: SHARNELL STATED REBECCA HENDRICKS, LORI HENDRICKS, JACK THORPE AND JOY MOHOROVICIC SHOWED UP AT HER HOUSE. SHARNELL SAID THE FEMALE DISTRICT ATTORNEY TOLD HER SON SCOTT THAT HE NEEDED TO GIVE THEIR SON (STERLING) TO HIS MOTHER. SHE STATED SCOTT HAD NO LEGAL RIGHTS TO THE CHILD. SHARNELL SAID THEIR IS NO CUSTODY AGREEMENT BETWEEN THE TWO. SHARNELL ADVISED THEY DIDN'T KNOW WHAT THEY COULD OR COULDN'T DO SO THEY GAVE STERLING TO REBECCA.

DEPUTY ACTION: DEPUTY JOHNSON COLLECTED A WRITTEN VOLUNTARY STATEMENT FROM SHARNELL AND SCOTT.

ADDITIONAL: EARLIER THAT DAY 6-25-16 AT APPROXIMATELY 10:10, I DEPUTY TORIX WAS CONTACTED BY INTERIM SHERIFF DAN DAVID IN REFERENCE TO A PHONE CALL BETWEEN DEPUTY JOHNSON AND REBECCA HENDRICKS. I ADVISED SHERIFF DAVID THAT I DIDN'T KNOW WHAT WAS SAID. SHERIFF DAVID STATED THAT THE CALL WAS NOT HANDLED PROPERLY AND THAT I NEEDED TO FIND OUT WHY WE DIDN'T ASSIST MRS. HENDRICKS. SHERIFF DAVID SAID THE FATHER SCOTT CHRISTY HAS NEVER HAD A PATERNITY TEST TO SHOW HE WAS THE FATHER SO THEREFORE HE HAS NO LEGAL RIGHTS TO THE CHILD. SHERIFF DAVID STATED MYSELF OR DEPUTY JOHNSON WILL GO AND ASSIST REBECCA ON RETRIEVING HER SON FROM HIS FATHER. I ADVISED SHERIFF DAN WHAT DEPUTY JOHNSON HAD TOLD ME IN REFERENCE TO REBECCA STATING HE IS THE FATHER AND THAT THEIR WAS NO DOCUMENTATION STATING WHERE THE CHILD WAS SUPPOSE TO BE. SHERIFF DAVID AGAIN TOLD ME THEIR IS NOTHING TO PROVE SCOTT IS THE FATHER. I WAS ADVISED TO CONTACT ASSISTANT DISTRICT ATTORNEY JOY MOHOROVICIC (918-706-6679) IN REFERENCE TO THE MATTER.

I CONTACTED ASSISTANT DISTRICT ATTORNEY JOY MOHOROVICIC WHO STATED SHE WAS AT THE RESIDENCE WITH LORI AND REBECCA HENDRIX WAITING ON MY ARRIVAL. JOY ADVISED ME THAT SCOTT HAS NEVER HAD A PATERNITY TEST AND IT HAS NEVER BEEN PROVEN AND/OR DOCUMENTED THAT HE WAS THE FATHER. JOY STATED HE THEREFORE HAS NO LEGAL RIGHTS TO THE CHILD. I CONTACTED DEPUTY JOHNSON
